

VWI WEBSITE PRIVACY POLICY

Thank you for your interest in Vision West, Inc. (“VWI”) and our website located at <http://www.vweye.com> (the “Site”). We are pleased to provide this privacy policy to inform you of our practices with respect to how we collect and use personally identifiable information about visitors to the Site. By using this website, you consent to the following terms.

What We Collect. The data that we regularly collect about visitors to our site (e.g., IP address, browser type, pages accessed, duration of visit, etc.) does not necessarily enable us to personally identify you, and that is not our intention. We do collect personally identifiable information about you and your company, including your user name, but only if you voluntarily provide it to us by registering and/or requesting information from us.

Cookies. To facilitate your use of the Site, VWI uses “cookies.” A cookie is a small amount of data that VWI’s servers transfer to your browser and that only VWI’s servers can read. We may use cookies to make us aware that a computer has previously accessed the Site. A cookie could also be used to store registration information so that a user does not need to re-input it on return visits. The use of cookies is now standard for most Web sites. If you are concerned about cookies, however, most browsers permit individuals to decline to accept cookies. In most cases, a visitor may refuse a cookie and still fully navigate the Site.

In order to properly manage the Site, we may anonymously log information on our operational system and identify categories of visitors by data type, such as domains and browser types, or collect nonpersonal information about your web viewing habits while you navigate the Site, such as navigation trends, hits per page/per user and time allocation. These statistics are reported in the aggregate to our webmasters. This is to ensure that the Site presents the best web experience for visitors and remains an effective information resource.

Use of Information. VWI uses your personally identifiable information primarily to provide you with periodic printed or e-mail communications about new products and services, discounts, special promotions or upcoming events. You may choose to provide personal information to VWI for a variety of reasons, including the following:

- Submitting resumes or work history information
- Contacting us for further information or to request materials
- Registering for events and conferences
- Registering to join our mailing list

Disclosure. VWI uses certain third party vendors (e.g., data storage and processing facilities) to assist VWI in providing our products and services. VWI may transfer your personally identifiable information to such vendors who have entered into a contract with VWI that protects the confidentiality of your information and permits the vendor to use it only as reasonably necessary to fulfill its contract with VWI. VWI may disclose your personally identifiable information to certain third parties who offer goods or services which we believe may be of

interest to you, unless you inform us that you do not wish to be included in offerings for such goods and services at the time of providing us with your personally identifiable information. VWI may disclose your personally identifiable information as it believes is reasonably necessary to comply with law, regulation or other governmental authority or to prevent harm to yourself or others. Finally, VWI may disclose your personally identifiable information upon a transfer or sale to another entity of all or substantially all of VWI's stock or assets in VWI's line of business to which this Privacy Policy relates or upon any other corporate reorganization.

Links. For your convenience, we may provide links to certain third party websites or referrals to certain third parties' products or services. If you choose to visit a third party's website or use its products or services, please be aware that the third party's privacy policy, and not the VWI privacy policy, will govern your activities and any information you disclose while interacting with the third party.

Security. Because any personally identifiable information you submit to VWI is purely voluntary and should not be of a particularly sensitive nature, we employ our standard security measures and do not use special encryption methods at this time.

Public Forums. VWI may make available to users, chat rooms, forums, message boards, and newsgroups. Any information disclosed in these areas, or otherwise submitted to VWI for publication, becomes public information and is no longer within the shield of this privacy statement. Use extreme caution when disclosing personal information through any of the above-mentioned communication mechanisms. In addition, VWI may use comments posted in public areas about the Site or VWI's services for editorial purposes or in promotional, advertising or marketing materials. Users who submit such comments in these public places on the Site grant a perpetual, royalty-free license to VWI to use such public information.

Collection of Information From Children. VWI has no interest in collecting information people under 18 years of age. If you are under the age of 18, please do not provide any personal information to VWI.

Policy Changes. VWI reserves the right to change this privacy policy, and will post any revisions on the Site. We encourage you to review this Privacy Policy regularly for any changes. Your continued use of the Site will be subject to the then-current privacy policy.
